- A letter of recommendation from your school, written by your principal, guidance counsellor, or teacher;
- A letter of support or confirmation from the not for profit youth program on which this application is based;
- An electronic transcript of your academic record, or a copy of your Course and Mark Details report.

### Mature Student Applications:

- Where a letter of recommendation from your school is not feasible, provide a copy of an essay of up to 300 words, describing your involvement as a leader or volunteer with an outdoor educational based association. Other circumstances, which may include employment history, may be relevant to the consideration of your application.

No other material will be presented to the judges. Materials will not be returned. Please retain a copy of this application for your records.

Only the successful applicant(s) will be notified by **September 1st, 2014**.
